On 8th of March 2024, Medpeople AB, reg. no. 559072-2699, was declared bankrupt by the Stockholm District Court. Otto Andersson at Walthon Advokater have been appointed as the bankruptcy trustee. Jenny Hildén and Jesper Ågren, also from Walthon Advokater are assisting with the bankruptcy administration.

Medpeople has developed a B2B digital staffing and recruitment marketplace tailored to the healthcare industry, featuring proprietary technical platforms. Medpeople provides its customers with consulting (staffing) and recruitment services for nurses and doctors.

The platform was primarily designed for staffing purposes, and many of the relevant support systems have been fully developed in-house. These include technology for managing consultants and customers, scheduling, time reporting, rating, payments and transactions.

At the time of the bankruptcy, Medpeople's system had 6980 consultants.

The Medpeople platform offers a comprehensive service, facilitating the scheduling and monitoring of both individual scheduled shifts and weekly assignments as well as the posting of recruitment advertisements. The infrastructure of the platform is based on a monolithic Python backend with a REST-API, supported by three separate frontend clients developed using React; a worker application for iOS and Android, a web based application for employers, and a web based admin panel for the system 's owner.
